We have taken into consideration: clinician's area(s) of expertise, a stated preference of a male or female clinician, a stated preference for a style of clinician, distance from campus, soonest available appointment, and/or whether or not the clinician is an in-network provider for a particular insurance.

When you call, talk to the clinician personally if possible. Indicate that you are looking at possible clinicians and gathering information to decide. Be ready to leave your phone number and a time you can be reached in case the clinician is unavailable when you call. It is important that you choose a clinician with whom you feel comfortable and at ease, since your treatment will involve working together as a team.

When contacting a clinician, there are several questions you might consider asking:

- What days and times are you currently available?
- Where is your office located?
- What is your approach to therapy?
- What are your fees/co-pays?
- Are you an in-network provider for (state the name of your insurance)?
- Will you directly bill my insurance company? (some providers will offer to give a receipt for you to submit to the insurance company for reimbursement)
- Do you have a sliding fee scale for students who are not insured?
- Do I have to pay "up front" for services?
